## MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF THE TEXAS PUBLIC FINANCE AUTHORITY

September 7, 2006

The Board of Directors (the "Board") of the Texas Public Finance Authority (the "Authority") convened in open meeting, notice duly posted pursuant to law (a copy of which notice is attached hereto as Exhibit "A") at 1:00 P.M., Thursday, September 7, 2006, William P. Clements Building, Room 410-B, Austin, Texas. Present were: Bert Mijares, Vice-Chairman; Mr. Vaughn Brock, Secretary; Ms. Linda McKenna, Member; Ms. Ruth Schiermeyer, Member; and Ms. Carin Barth, Member.

Representing the Authority's staff were: Ms. Kimberly Edwards, Executive Director, Ms. Judith Porras, General Counsel, Mr. John Hernandez, Ms. Gabriela Klein, and Ms. Paula Hatfield.

### Item 1. Call to Order.

Mr. Mijares called the meeting to order at 1:05 P.M.

### Item 2. Work session for new Board Member orientation.

Ms. Edwards stated that during the last session of the Legislature a requirement that all board members receive open meetings training was passed. Sitting members must complete the training by the end of the year and new appointees must complete the training within 90 days of taking office. The board members in attendance completed this mandatory training by viewing the training program provided by the Attorney General's Office on DVD.

Ms. Edwards reviewed the Authority's current debt programs and upcoming bond sales. She introduced the Authority's Deputy Director, John Hernandez, who oversees all the accounting, IT, Master Lease Program and debt, and Gabriela Klein, the Authority's financial analyst who maintains spreadsheets and records on existing and projected debt service and arbitrage rebate compliance.

Ms. Edwards presented information on the Authority's outstanding debt, interest rates, the issuance process, including the selection process for financial advisors, bond counsel and underwriters, and the Authority's SWAP policy. Discussion ensued.

Ms. Schiermeyer suggested that in the future the Board formally confirm that the open meeting was posted in compliance with the Open Meetings Act. The board agreed. Staff will include the *Texas Register* posting confirmation for each meeting, behind the agenda for board members' confirmation.


**Item 3. Other Business**
