MINUTES OF THE MEETING OF THE WORK SESSION OF THE BOARD OF DIRECTORS OF THE TEXAS PUBLIC FINANCE AUTHORITY

May 2, 2019

The Board of Directors (the "Board") of the Texas Public Finance Authority (the "Authority") convened in open meeting, notice duly posted pursuant to law (a copy of which is attached hereto as Exhibit "A") at 12:00 noon., Thursday, May 2, 2019 at the William P. Clements, Jr. Building, Room 411, 300 West 15th Street, Austin, Texas. Present were: Mr. Billy M. Atkinson, Jr., Chairman; Ms. Ruth C. Schiermeyer, Vice-Chair; Mr. Ramon Manning, Member; Mr. Robert T. Roddy, Member; and Mr. Rodney K. Moore, Member. Also in attendance: Mr. Joseph E. Williams, appointed to the Board and awaiting final Senate confirmation.

Representing the Authority's staff were: Lee Deviney, Executive Director; John Hernandez, Deputy Director and Kevin Van Oort, General Counsel.

In attendance were the following persons, representing the indicated entities: Blake Roberts and Karlos Allen, PFM Financial Advisors; and Curtis Flowers, Loop Capital Markets LLC.

Mr. Atkinson called the meeting to order at 12:05 p.m. and noted the presence of a quorum.

Item 1. Confirm meeting posting compliance with the Open Meetings Act.

Mr. Atkinson confirmed that the meeting was duly posted with the Secretary of State.

Item 2. Excuse absences of board members, if necessary.

Chairman Atkinson introduced Joseph "Joe" E. Williams, Governor Abbott's newly appointed member to the TPFA Board. Chairman Atkinson stated that Mr. Williams still had to be confirmed

by the Senate and he was participating in the work session as part of his orientation to the TPFA Board.

Action: Motion by Ms. Schiermeyer to excuse the absences of Mr. Moody, Mr. Roddy and Mr. Alley. Second by Mr. Manning.

The motion passed unanimously.

Item 3. Legislative Update:

a. Legislation

Mr. Deviney discussed the legislative bills that staff has been tracking. Mr. Deviney explained the differences between the House and the Senate budgets as related to TPFA, as laid out in the "issue docket" for the General Appropriations Act.

b. Sunset Commission Reports

Mr. Deviney stated the agency is monitoring sunset bills which might impact four of TPFA's client agencies. Texas Historical Commission (THC) includes a recommendation to transfer eight significant properties from the Texas Parks and Wildlife Department to the THC. The bill would continue THC for 12 years. Staff will review the proposed transfers to ensure that any bond funded projects would not be impaired, and that funding remains in place for general obligation bond debt service or revenue bond lease payments.

Texas Military Department would be continued for another 12 years. No identified impact to TPFA.

Texas Department of Public Safety would be continued for another 12 years. No identified impact to TPFA.

Texas Windstorm Insurance Association (TWIA) is not subject to being abolished through the sunset process, but is subject to sunset review. Introduced sunset related legislation would not impact TPFA. However, TPFA is aware of proposals that, if incorporated into legislation, would impact TWIA's funding stack and TPFA's ability to issue debt in the future.

Agency Budget

Mr. Deviney stated both the House and the Senate have passed their versions of the General Appropriations Act for the 2020-21 biennium. The agency will not receive funding for all of the requested items, however, he reported the agency's budget is in good shape. Key items that were requested are funding for a merit pool for staff and funding for ongoing accounting (CAPPS) and Debt Management System

related projects, as well as an IT refresh. Both the House and Senate versions would provide authorization for an increase to the Executive Director salary cap.

Item 4. Service provider pools: RFP evaluation process and procedures for designating service provider pools.

Mr. Roddy arrived at the meeting at 1:15 p.m.

In January 2019 the TPFA Board met and voted to issue Request for Proposals (RFP's) to update the service provider pools including: underwriters, bond counsel and financial advisors. Mr. Deviney reported the RFP for underwriting services was issued on April 17 and responses were received from 31 firms. Mr. Deviney said he expects the analysis to be completed in time for a July 11, 2019 Board meeting.

Mr. Deviney stated the RFP for bond counsel should be released shortly. Action for both the bond counsel and financial advisors should be ready for Board action in August or September.

Item 5. Staff Update:

a. Personnel Update

Mr. Deviney introduced TPFA's newest employee Clayton Sanders. Mr. Sanders joins the agency as an Accountant III.

b. Insurance Update - Property & Casualty

Mr. Deviney informed the board that TPFA has renewed it's expiring property insurance policy through the Statewide Property Insurance Program administered by the State Office of Risk Management (SORM) for the period beginning April 30, 2019 through April 30, 2020.

c. State Auditor's Office Risk-Assessment

Mr. Deviney informed the Board that the agency's annual Risk Assessment has been submitted to the State Auditor's Office.

Item 6. Future agenda items and meeting dates.

Mr. Deviney recommended July 11 for the next Board meeting.

Item 7. Adjourn.

Mr. Atkinson adjourned the meeting at 1:35 p.m.
