The bill transfer legal authority for the administration of the program to the Governor's Economic Development Bank. No substantial change in debt issuances expected. Effective 9/1/09.
HB 4409	Jackson	Emergency Preparedness and Management	Authority to issue bonds to pay for excess losses due to hurricanes added. Intended that the TPFA prepare a commercial paper program to be available to sell debt, post-event. Effective immediately on Gov's signing.
